#### **General Price List**

These prices are effective April 1, 2013, but subject to change without notice.

#### **CREMATION**

The goods and services listed are those we can provide for you. We provide an exclusive Direct Cremation service. This includes transportation from place of death, transportation to the crematory, the cremation process, returning the remains to you in an urn of your choice and filing the death certificate.

Our fee for this service is 895.00 (this includes the container required by the crematory).

Should you provide an acceptable container, the fee is \$870.00

We can provide Urns at \$30.00 and up. Cremation usually takes anywhere from 7 to 21 business days. You can request a RUSH for an additional fee of \$200 for a 7 day turnaround.

### **Basic Professional Services of Funeral Director & Staff** **\$695.00**

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. This is a basic fee we charge every family which includes availability of staff to respond to initial call for service, arrangement conference to assist families in arranging a personalized service, coordination of details with clergy, cemetery, crematory, florists, government escorts, musicians, health department, common carrier and placement of obituary notices as determined by a family and/or other parties responsible for disposition. This fee includes a proportionate share of the establishment's occurred overhead costs.

### **Embalming** **\$550.00**

This service provides professional care and embalming of the deceased. Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

### **Graveside Service** **\$1350.00**

Basic services of funeral director and staff which includes but is not limited to: meeting with the family to gather necessary information, preparing and obtaining required signatures on death certificate, filing death certificate

with the health department and picking up the certified copies of the death certificates, obtaining required permits, placing news notices and obituaries in newspapers (does not include newspaper charges) and coordinating service details.

### **Forwarding Remains to Another Funeral Home** **\$1900**

This charge includes transfer of remains within 15-mile radius, minimum services of staff, securing necessary permits, embalming, and local transportation (excluding shipping charges and shipping container). This charge does not include, dressing and casketing or facilities and staff for visitation or funeral services.

### **Receiving Remains from another Funeral Home** **\$1595**

This charge includes minimum services of staff for acceptance of delivery and/or transportation from Colorado Springs airport and transportation in a van to cemetery or crematory within 15-mile radius. This charge does not include visitation or funeral services.

### **Cash Advanced Items**

Cash advanced items are those items that are selected by the family that is not offered by the funeral home but that the funeral home will take care of in advance. These items may be but are not limited to: Clergy Honorarium, Musician, Cemetery, Sales Tax, Airline Charges, Hair Stylist, Obituaries, Escorts, Death Certificates, Church, Ect....

### **CREMATED REAMINS**

We will hold cremated remains for a period of one 30 days. If the remains are not claimed after the 30 days we will dispose of them at our discretion.

### **DEATH CERTIFICATES**

Certified copies of the Death Certificate are available from the County Health Dept. We can assist you in determining the number of certified copies needed and place the order with the state for you.

### **SOCIAL SECURITY**

We will notify Social Security of the death; however, you will need to file for any benefits. Social Security will not pay us. Please see our web site for further information. We do not guarantee SSI will stop any occurring payments.

**INSURANCE/Third Party Billing** – You will need to contact your insurance company for any and all claim forms.

If billed by our company, we have a Filing Fee of \$300.

### **ID VIEWING/FAMILY CLOSURE VIEWING or ANY OTHER SERVICE**

We do not guarantee all circumstances can be upheld. If applicable, ID Viewing can be arranged for a 1 hour period by IMMEDIATE FAMILY ONLY!(up to 10 people) The body will not be embalmed however, certain aspects of preparation work are done. This occurs on a dressing table and does not use a casket. Our charge is \$125 w/no autopsy
